FOOD FOR THOUGHT!!

Ever wonder what those old "sayings" mean and where they came from?

Most people got married in June because they took their yearly bath in May, and still smelled pretty good by June. However, they were starting to smell, so brides carried a bouquet of flowers to hide the body odor. Hence, the custom today of carrying a bouquet when getting married.

Baths consisted of a big tub filled with hot water. The man of the house had the privilege of the nice clean water, then all the other sons and men, then the women, and finally the children. Last of all, the babies. By then the water was so dirty you could actually lose someone in it. Hence the saying, "Don't throw the baby out with the bath water."

Houses had thatched roofs – thick straw – piled high, with no wood underneath. It was the only place for animals to get warm, so all the cats and other small animals (mice, bugs) lived in the roof. When it rained it became slippery and sometimes the animals would slip and fall off the roof. Hence the saying, "It's raining cats and dogs."

There was nothing to stop things from falling into the house. This posed a real problem in the bedroom where bugs and other droppings could mess up your nice clean bed. Hence, a bed with big posts and a sheet hung over the top afforded some protection. That's how *canopy beds* came into existence.

The floor was dirty. Only the wealthy had something other than dirt. Hence the saying "dirt poor." The wealthy had slate floors that would get slippery in the winter when wet, so they spread thresh (straw) on the floor to help keep their footing. As the winter wore on, they added more thresh until, when you opened the door, it would all start slipping outside. A piece of wood was placed in the entranceway. Hence the saying a "threshold."

In olden days, cooking was done in a big kettle that always hung over the fire. Every day they lit the fire and added things to the pot. They are mostly vegetables and did not get much meat. They would eat the stew for dinner, leaving leftovers in the pot to

get cold overnight and then start over the next day. Sometimes the stew had been there for quite a while. Hence the rhyme, "Peas porridge hot, peas porridge cold, peas porridge in the pot nine days old."

Sometimes they could obtain pork, which made them feel special. It was a sign of wealth that a man could "bring home the bacon." They would cut off a little to share with guests and would all sit around and "chew the fat."

Those with money had plates made of pewter. Food with high acid content caused some of the lead to leach into the food, causing lead poisoning death. This happened most often with tomatoes, so for the next 400 years or so, *tomatoes were considered poisonous*.

Bread was divided according to status. Workers got the burnt bottom of the loaf, the family got the middle, and the guests got the top, or "upper crust."

Lead cups were used to drink ale or whisky. The combination would sometimes knock the imbibers out for a couple of days. Someone walking along the road would take them for dead and prepare them for burial. They were laid out on the kitchen table for a couple of days and the family would gather around and eat and drink and wait and see if they would wake up. Hence the custom of holding a "wake."

England being old and small the local folks started running out of places to bury people. So they would dig up coffins and would take the bones to a "bone-house" and reuse the grave. When reopening these coffins, 1 out of 25 coffins were found to have scratch marks on the inside and they realized they had been burying people alive. So they would tie a string on the wrist of the corpse, lead it through the coffin and up through the ground and tie it to a bell. Someone would have to sit out in the graveyard all night (the "graveyard shift") to listen for the bell; thus, someone could be "saved by the bell" or otherwise be considered a "dead ringer."

CPSC, Full Speed Ahead Announce Recall of Scatto Bicycle Wheel Quick Releases

WASHINGTON, D.C. - The U.S. Consumer Product Safety Commission announces the following recall in voluntary cooperation with the firm below. Consumers should stop using recalled products immediately unless otherwise instructed.

Name of product: Full Speed Ahead (FSA) Scatto bicycle wheel quick releases

Units: About 1,375 sets

Manufacturer: Full Speed Ahead, Inc. of Woodinville, Washington

Hazard: An internal part in the lever mechanism can break, reducing clamping effectiveness and rendering the unit inoperable, potentially causing a bicyclist to fall.

Incidents/Injuries: There have been 12 reports of the quick release mechanism failing, but no injuries have been reported.

Description: The Full Speed Ahead Scatto quick release was sold as standard equipment for RD-400 and XC-300 bicycle wheelsets and also separately. The levers are laser etched "FSA" and the end pieces have a distinctive round shape.

Sold at: Bike shops, catalogs, and Web sites sold the recalled quick releases nationwide from October 2003 through September 2004 for \$49.95 per set.

Manufactured in: Taiwan

Remedy: Free replacement. Consumers should stop using the quick releases and call Full Speed Ahead toll-free at (877) 743 3372 from 8 a.m. to 5 p.m. PT Monday through Friday, or write to Full Speed Ahead, Inc., 12810 NE 178th St #102, Woodinville, WA 98072.

WASHINGTON, D.C. - The U.S. Consumer Product Safety Commission announces the following recall in voluntary cooperation with the firms below. Consumers should stop using recalled products immediately unless otherwise instructed.

Name of product: "Forte Flyte OS" and "Weyless CF200"

Carbon Handlebars **Units**: About 300

Manufacturer: Performance Inc. and Supergo Inc., of

Chapel Hill, N.C.

Hazard: The handlebars can develop cracks that may not be visible, which can cause the handlebar to break without warning, resulting in serious injury or death.

Incidents/Injuries: Performance Inc. has received one report of handlebars breaking. No injuries were reported.

Description: Only the Performance Forte Flyte OS Carbon Road handlebars and the Supergo Weyless OS Carbon Road handlebars are included in the recall. Both handlebars are natural carbon gray. The Performance Forte Flyte has printing along the top of the handlebar. On the left front is "Forte" in red, and on the right front is "Flyte." On the right top is "ACT" in large white letters and "Advanced Carbon Technology" in smaller letters. The Supergo Weyless handlebar says "Weyless" in white and has a red oval with "Full Carbon Composite" printed in white. On the left side is "CF" in red, "200" in white, and "Hi-Pressure Solid Compaction" in white. The Performance handlebars were sold separately, not as part of a bicycle. The Supergo handlebars were sold separately and as part of the 2004 Scattante SC-R bicycle.

Sold at: The recalled handlebars were sold by mail order, Web sites, and Performance and Supergo retail stores for about \$169. The Scattante bike equipped with the defective handlebars sold for \$3,295.

Manufactured in: Taiwan

Remedy: Consumers should stop using the bicycles with these handlebars immediately and return the handlebars to the nearest Performance or Supergo stores for a replacement or refund.

Name of product: Rainier Mountain Bicycles

Units: About 160

Distributor: Giant Bicycle Inc., of Newbury Park, Calif. **Hazard**: The front brake mounting tabs can break, causing the brakes to fail and the rider to lose control of the bicycle. **Incidents/Injuries**: The company has received six reports of the tabs breaking. No injuries have been reported.

Description: The recall involves only 2004 Rainier model mountain bicycles with Marzocchi EXR Comp front forks. Model numbers included in the recall are 333502, 333503, 333504 and 333505. The bicycle is blue and silver and is made of aluminum. The names "Giant" and "Rainier" are printed on the frame of the bicycle. Earlier models of this bicycle are not included in this recall.
