

#### MINUTES OF THE TRI-COUNTY BICYCLE ASSOCIATION BOARD OF DIRECTORS MEETING

#### Foster Community Center—Lansing March 6, 2007

Board Members present included Dick Janson, Sue Viele, Dick Sulin, Charla Scheidler, Al Simons, Ellen Lamb and Kris Stairs. Also present were club members Katie Donnelly and Steve Schuesler.

#### Reports

1. <u>Minutes/Secretary's Report</u>: Minutes of the February meeting were presented for review. Sue Viele made a motion to approve the minutes as presented; the motion was seconded by Al Simons and carried unanimously.

Charla Scheidler presented correspondence that was received from Mary Hunker, with a donation in the amount of \$50, in memory of Barbara Reader.

2. <u>Treasurer's Report</u>: Dick Sulin presented a financial report through February 26, 2007. It was noted by Charla Scheidler that check #2615 should be recorded in the Ride Program Incentives account rather than the Club Promotions account. A motion to approve the report with the suggested correction was made by Dick Janson and seconded by Kris Stairs. The motion carried unanimously.

Discussion took place regarding a professional review of the accounting records. Dick Sulin made a motion that an expenditure of up to \$1,500 be approved. The motion was seconded by Sue Viele and carried unanimously.

- 3. <u>DALMAC</u>: Al Simons reported that DALMAC applications were mailed on February 12 and the online application was activated on February 14. The 4-day West route was full within one week and the 5-day full within two weeks. Roughly 440 openings remain over the other 3 routes.
- 4. <u>*Ride Incentive Program:*</u> Ellen Lamb reported that the order for the 2006 awards should be placed around March 13.
- 5. <u>*T-Shirt Ride:*</u> Al Simons reported that plans for the 2007 event were underway and the Laingsburg High School and the Shiatown Park were both reserved.

#### **Old Business**

- **Budget**—Dick Sulin presented the 2007 budget. Discussion took place regarding the omission of expenses for the WOW ride. A motion to amend the budget to reflect \$9,500 for expenses for the WOW ride was made by Dick Janson and seconded by Charla Scheidler. The motion carried, Dick Sulin opposed and Al Simons abstained. Charla Scheidler made a motion to approve the amended budget; the motion was seconded by Sue Viele and carried with Dick Sulin opposed.
- **TCBA Northwest Tour**—Dick Janson provided an update of plans to date. Applications were mailed to members in the February *Chainwheel Chatter* and are coming in, but no totals were available.
- Officers and Directors Bonding Limits—Charla Scheidler presented information from Dwayne Scheidler regarding the increased limits requested; a copy will remain on file in the secretary's records. Although the requested amount was not approved by the insurance company, due to the possibility of a stacking of limits collectively among board members, a "blanket" combined single limit of \$400,000 covering all board members and the DALMAC treasurer under one limit was approved.

#### New Business

• Dick Janson reported on correspondence received from LMB requesting club liaisons to help them with advocacy, education and promotion. The information will be reviewed further before a determination on who to recommend is made.

#### SRAM Recalls Bicycle Brake Caliper Sets

The U.S. Consumer Product Safety Commission, in cooperation with SRAM Corp., has announced a voluntary recall of SRAM Force road brake caliper sets. The brake caliper sets could break and detach from the bicycle's fork or frame and cause the rider to lose control and crash.

The recall involves the SRAM Force Road Brake Calipers sets sold as aftermarket components. The brake caliper sets have "SRAM Force" and some have a date or production code embossed on the unit.

The sets may have been installed on certain Specialized, Trek, Fuji; Scott USA, Bianchi, Kuota, Orbea, Kestrel and Sampson bicycles. The recall includes sets sold at specialty bicycle retailers nationwide from July 2006 through January 2007 and bicycles which included these sets through March 2007. Consumers should stop using bicycles equipped with these brake caliper sets immediately and contact their bicycle retailer for a free replacement.

#### The Bike Report Ron Truax

An article I wrote about rebuilding an old bike which was published previously in this newsletter. Well, except for a clear vinyl chain-stay protector, it's finished, together, done. As previously stated, it was originally a mountain bike that I was converting into a touring bike for self-contained travel. Oh, it didn't have to be, but that's what was in the back of my head when I was sorting it all out. The only problem now is deciding what to do with it. You see, I already have an excellent bike, which I've used for several trips around the country. I'm not new at this. But it seems a shame to keep it as backup; it would be such a waste. I guess I can sort all that out later.

Now I know you'll all have to take my word for it, but the new finish was well worth the money. Two applications of powder coating, brilliant red and clear, turned out great. It returned home looking like a brand new frame.

While the frame was being worked on, I was still trying to collect enough parts to assemble the finished bike. Converting a mountain bike into a touring bike seemed like a straightforward proposition. If it worked, I'd be a star. If not, I'd just be another page forgotten in history. But there again, what else is new?

Well, I was able to come up with a Shimano Deore XT drive train for it, almost. It has both derailleurs with matching indexed bar-end shifters. But for a crankset, I used a Shimano Ultegra triple with 50-40-28 tooth chain rings, leading to a 12-28 Shimano 7speed cassette with a KMC-SS chain. I then found a set of Shimano Exage brake handles with brake quick releases built right into the handles. Lastly, I custom built a set of wheels: Shimano hubs, DT-Swiss spokes, and Sun Metal CR-18 rims. Technically, they're 36hole (spoke) wheels, built 4X for strength. This is a bike that can be loaded down. I know I'm biased, and it may look different with 26" wheels, but it's way too cool.

Lastly, this beauty is large enough to fit me, and was ridden by someone an inch taller than me—6'3". But because it's a mountain bike converted to a touring bike, I believe it can accommodate someone much shorter. So, rethink that old bike in the basement or out in the garage; it may just cultivate an idea for the future.
