BOARD OF DIRECTORS MEETING  
Foster Community Center - Lansing  
May 4, 2010**

Board members present included Roger Nelson, Lenny Provencher, Patricia Trudgen, Linda Antinori, Kris Stairs, and Donovan Riley. Also present were club members Katie Donnelly, Wendell Proudfoot, and Bill Savage.

President Roger Nelson called the meeting to order at 6:30 p.m.

**Reports:**

1. **Vice-President's Report:** Our May meeting will consist of the presentation of awards to the winners of the Bicycle Safety Poster contest and a short summary of their programs by the DALMAC Grantees. Bill Savage and Tim Potter will speak on their experiences at the National Bike Summit in Washington, D.C. at the June meeting.
2. **Secretary's Report:** Linda Antinori presented April's Minutes to the Board for approval. Pat Trudgen made a motion to accept the minutes with corrections. Dick Sulin seconded it, and the motion passed unanimously.

**MICHIGAN RANKED 12th!**: (*From the League of American Bicyclists*) The League of American Bicyclists has announced our first annual ranking of Bicycle Friendly States, scoring all 50 states on more than 70 factors. The states were scored on responses to a questionnaire evaluating their commitment to bicycling and covering 6 key areas: legislation; policies and programs; infrastructure; education and encouragement; evaluation and planning; and enforcement.

The highest and lowest scoring states overall were:

**FROM THE LEAGUE OF MICHIGAN BICYCLISTS** ([www.lmb.org](http://www.lmb.org)):

The second House Transportation Committee hearing on complete streets legislation, HB 6151 and 6152, saw the room once again packed with supporters of the policies. The legislation, which seeks to move Michigan away from auto-centric road designs, and ensure the needs of all roadway users has attracted strong support from a broad range of advocates.

John Lindenmayer, Associate director of the League of Michigan Bicyclists, was the first to testify and took the opportunity to present the Committee with a letter signed by the owners of 25 Michigan bicycle shops. As

co-chair of the Michigan Complete Streets Coalition, he also reiterated the numerous community benefits of complete streets and provided a brief synopsis of the national, statewide and local complete streets efforts currently underway.

Lindenmayer also fielded the first of several questions from various Representatives about funding for the policy. Rep Switalski, who sponsored the bill, backed up Lindenmayer's responses by refuting erroneous claims that the bills represent an unfunded mandate. Switalski reminded the Committee members that "language in the bill gives an exemption for excessive costs," and added "It doesn't cost anything to think differently and to plan differently."
