MINUTES OF THE TRI-COUNTY BICYCLE ASSOCIATION BOARD OF DIRECTORS MEETING

Foster Community Center - Lansing December 7, 2010

Board members present included Roger Nelson, Lenny Provencher, Patricia Trudgen, Kris Stairs, Donovan Riley, and Dick Sulin. Linda Antinori joined the meeting at 8:15. Also present were club members Katie Donnelly, Dean Brailey, Steve Leiby, Ken Hendricks, Dwayne Scheidler, and Janet Weber.

President Roger Nelson called the meeting to order at 6:35 p.m.

- **Additions to the Agenda:** Joe Adams request for donations to the 2 State Parks used for Summer Tour last year.
- **Correspondence Received:** Pat Trudgen received a thank you note from NBTDA for sponsoring a break at the conference.

Reports:

- 1. <u>President's Report:</u> Roger Nelson reported that we had a good transition meeting at the Kellogg Center and a lot of good ideas were brought up including:
 - a. Adding to incentive Committee to the Volunteer Appreciation Dinner
 - b. Supporting River Trail maintenance Steve Leiby will check into this.
 - c. Adding a short (2 day?) DALMAC route to encourage younger or new riders
 - d. Establish a publicity/advertising committee
 - e. Establish a bicycle advocacy committee
- 2. <u>Vice-President's Report</u>: Lenny reported that 80 people had signed up for our Christmas Party at the Demmer Shooting and Training Facility. Shooting activities start at 5 and dinner will be served at 6.
- 3. <u>Secretary's Report</u>: Dick Sulin made a motion to accept the Minutes with a correction. Pat Trudgen seconded it, and it passed unanimously.
- 4. <u>Treasurer's Report</u>: Dick Sulin presented November's Treasurer's Report to the Board for approval. Lenny Provencher made a motion to approve the Financial Reports as presented, Pat Trudgen seconded it and the motion passed unanimously.
- 5. <u>Events Director:</u> Patricia Trudgen reported that she has had 2 DALMAC meetings thus far. Jeff Smith has taken over the buying committee for DALMAC; discussion has begun on jersey design and give-a-ways. There will be a link on the DALMAC web site to an independent agency for cancellation insurance for this event. DALMAC will not be responsible for the insurance and the claims that arise from it.
- **6.** <u>Ride Incentives:</u> Kris Stairs reported that the incentive jackets are in and being distributed. The 2010 incentive letter and form is ready to go and will be emailed to Steve Schuesler.
- 7. <u>Northwest Tour:</u> Dick Sulin stated that they grossed \$23,190 on Northwest Tour last year with 184 riders participating. We have a contract for 2011 with the same campground and are waiting to hear if the Empire campground will accept our proposal.

- **8.** <u>Membership</u>: Dean Brailey reported that he is waiting to hear from Wendell on a date to go check out possible new software for the membership data base.
- 9. **DALMAC Fund:** The DALMAC Fund web page is updated and ready to go.

Old Business:

- Alaeidon Township is requesting that if we place port-a-johns at the Township Hall that
 they be lockable to prevent kids from using them without their parents. Edie Belcher is
 looking into possibly moving the ride to an elementary school near the township hall.
- Board Protocol was brought up for vote. Dick wanted the Board to meet in closed session to discuss this. Donovan made a motion to put the Board Protocol into effect as quickly as possible with the stipulation that it needs to be reviewed annually by the current Board to add, delete, or modify items as needed. Pat seconded the motion and Dick moved that we table the issue with no second. Roger called for a vote and it passed 4-1.
- Roger will ask Nancy Krupriarz for clarification of what the TCBA logo will be used for.

New Business:

- Joe Adams asked the Board for a donation of \$1,000 to both Algonac State Park and Lakeport State Park. Lenny made a motion to give Joe the authority to do so, Pat Trudgen seconded the motion and it passed unanimously.
- Discussion was held on establishing a Bicycle Advocacy Committee. If we want a
 Board member in charge of this, then the club by-laws would have to be changed.
 Steve Leiby will research this and present it to the Board and then to club membership if need be.
- Katie Donnelly shared that the cost of the Poster Contest should be about the same as last year. Letters are sent to the schools and they decide how to disseminate the information. It is also publicized in local newspapers and on our web site.
- Dick Sulin proposed background checks on club officers and ride leaders. Discussion was held and it was pointed out that it is already hard to get people to volunteer and if this is instituted it will make finding volunteers even harder. Issue was dropped due to non support.

The meeting adjourned at 8:15 p.m. and the Board went into a closed session.

WE HAVE NO RIDES SCHEDULED THIS MONTH

NORTHWEST TOUR 2011

Welcome to the 5th annual NorthWest Tour. This ride is sponsored by the Tri-County Bicycle Association (TCBA). It is our sincere hope that each of you will have a wonderful experience riding the NorthWest Tour.

On Wednesday, we have a short "dinner" ride to Glen Arbor. The tour begins on Thursday, with two nested loops toward the east. These are 54 miles to Traverse City and 34 miles through Lake Ann. There is an optional extended route of 46 miles to Old Mission Point for the long route. Friday has a pair of nested loops to the south through Honor. The 58-mile long route then passes through Benzonia and Frankfort. The 30-mile loop turns northwest out of Honor. Both loops then go to Empire.

Saturday's routes travel to the north. The 82-mile loop goes to Northport with an optional 23-mile round trip to Leelanau State Park. The 38-mile loop turns south after Little Traverse Lake. Sunday's 29-mile route goes along the Sleeping Bear Dunes National Seashore. This includes an optional ride on Pierce Stocking Drive and the Dune Climb. There is a \$5 daily fee for these attractions.



The area has its share of hills and so the routes do too. Some are up, some are down.

Some are tall and some are not so tall. While the short routes for each day have less mileage they still will have their challenges.


