Board members present included Roger Nelson, Steve Leiby, Patricia Trudgen, Linda Antinori, and Dean Brailey. Also present were club members Tom Martin, Ken Hendricks, Katie Donnelly, Wendell Proudfoot, Jeff Dillingham, Pat Harrington, Lenny Provencher, Janet Weber, and Dick Janson.

President Roger Nelson called the meeting to order at 6:30 p.m.

Dean Brailey made a motion to approve the Agenda as presented, Linda Antinori seconded the motion and it passed unanimously.

#### **Reports:**

- <u>Minutes:</u> Secretary Linda Antinori presented April's Minutes to the Board for approval. Dean Brailey made a motion to accept the Minutes with the stipulation that the Board's Executive session held on April 12, 2011 be added to the Minutes. Dean Brailey seconded it, and the motion passed unanimously.
- <u>President's Report:</u> Roger Nelson reported that a small group of club members who are interested in promoting TCBA met before the Board meeting to brain storm ideas and the results look promising. He is still looking for a person willing to take on an advocacy role for the club.
- <u>Vice-President's Report:</u> Roger Nelson reported in Ray Bailey's absence that Carrie Irons will be the speaker for our June club meeting. Our Christmas Party is set for Sunday December 4 at City Limits Bowling Lanes in Mason. Bowling, shoe rental, pizza, and pop will be provided from 2 to 4 p.m.

<u>Treasurer's Report:</u> Steve Leiby presented April's Financial Reports to the Board for approval. Linda Antinori made a motion to accept the Report as presented; Dean Brailey seconded the motion and it passed unanimously. Steve also reported that we had no response from Murdock Jemerson on the River Trail Project.

- **Events Director:** Pat Trudgen reported to date that we have 1,623 riders' registered on all 5 routes, which is down a little from last year. She is still looking for 6 volunteers on DALMAC: 4 SAG drivers and 2 truck drivers.
- <u>Incentive Committee:</u> Linda Antinori reported that all Level incentives are in and will be available at club meetings through July due to our inability to get all items ordered in at one time.
- <u>Northwest Tour:</u> Jeff Dillingham reported that they have 212 people signed up and just have to tie up a few loose ends.
- <u>**T-Shirt Ride:**</u> Pat Trudgen reported that everything is set for the T-Shirt Ride, including food and rest stops.
- **DALMAC Fund:** Tom Martin of The DALMAC Fund Committee reported that the DALMAC Fund Committee had received 21 applications this year and recommended 11 grants for a total of \$81, 200. The grants recommended by the Committee are as follows:

Share-a-Bike (purchase bike parts for bike give aways)	\$3,000
Kids Repair (bike repair program w/ staff costs fund raising)	\$3,000

Linda Antinori made a motion to approve opening the account above mentioned, Dean Brailey seconded the motion, and it passed unanimously.

#### **Bicycle Helmets Recalled by Bell** Sports Due to Head Injury Hazard

WASHINGTON, D.C. - The U.S. Consumer Product Safety Commission and Health Canada, in cooperation with the firm named below, today announced a voluntary recall of the following consumer product. Consumers should stop using recalled products immediately unless otherwise instructed. It is illegal to resell or attempt to resell a recalled consumer product.

Name of Product: Full-face bicycle helmets

Units: About 31,100 in the United States, and about 2,500 in Canada

Importer: Bell Sports, of Scotts Valley, Calif.

Hazard: The plastic buckle that connects the chin straps can fail, causing the helmet to come off the wearer's

head. This poses a head injury hazard to riders in the event of a fall.

Incidents: The firm has received one report of a buckle failing during an accident, resulting in an injury that required stitches below the wearer's eye.

Description: This recall involves Bell Exodus full-face helmets with a plastic

Manufactured in: Taiwan.

Remedy: Consumers should stop using the helmets immediately and contact Bell Sports for a replacement or refund.


