# MINUTES OF THE TRI-COUNTY BICYCLE ASSOCIATION BOARD OF DIRECTORS MEETING

Foster Community Center - Lansing January 4, 2011

Board members present included Ray Bailey, Steve Leiby, Patricia Trudgen, Linda Antinori, Kris Stairs, and Dean Brailey. Vice- President Ray Bailey presided over the meeting in President Roger Nelson's absence. Also present were club members Katie Donnelly, Lenny Provencher, Wendell Proudfoot, Ken Hendricks, and Janet Weber.

Vice-President Ray Bailey called the meeting to order at 6:33p.m.

**Additions to the Agenda:** Linda Antinori made a motion to accept inclusion of the presentation of the DALMAC Financial Reports and change of the DALMAC PO box number to the Agenda. Dean Brailey seconded the motion and it passed unanimously.

#### Reports:

- 1. <u>President's Report:</u> Ray Bailey reported that President Roger Nelson had contacted him about further discussion on establishing a bicycling advocacy position within TCBA. Steve Leiby has volunteered be the advocacy person for the TCBA. Lenny Provencher mentioned that the Mid-Michigan Alternative Transportation Committee meets once a month on Tuesdays. The matter was tabled until next month for further discussion. Roger is also interested in establishing a publicity campaign to promote TCBA. - Ken Hendricks presented the DALMAC Financial Statement to the Board. The DALMAC Fund split was \$81, 643 and the TCBA split was \$86,943. In 2009 the Board moved to not transfer the DALMAC funds into our account until March to allow the DALMAC Committee the use of these funds as needed for early expenses. This move eliminated the need for the previously retained earnings of \$10, 000 that DALMAC held back from the club. Linda Antinori made a motion to return the \$10,000 retained earnings figure to the TCBA accounts from DALMAC, Dean Brailey seconded the motion and it passed unanimously.
- The Board discussed the purchase of a new computer for Janet Weber, *Chainwheel Chatter* editor, and the software she would need. The matter was tabled until our next meeting.

#### **TOURING THE WHITE PINE TRAIL**

On October 2-3, 2010 I took part in my first Tour of the White Pine Trail which is sponsored by the Friends of the White Trail who maintain the 92-mile trail, spanning 92 miles between Grand Rapids and Cadillac. The trail consists of four paved sections, about half the length of the trail, with the rest a hard packed, two-track. Typically, I ride on the paved portion between Riverside Park in Grand Rapids and Sand Lake. However, during a few DALMAC rides, I have ridden the paved portion between Big Rapids and Reed City.

I completed this tour using my cyclocross bike, which I think is the ideal bike for the ride, but a majority of riders used mountain bikes. The one road bike belonged to TCBA member Jim Steenwyk, from Dorr, who would leave the trail on the non-paved part and take parallel roads to get back to the paved part of the trail.

Saturday morning I woke to a temperature in the 30's with the high slated to be in the low 40's, about 15-20 degrees colder than usual. Therefore, I opted for my winter weight biking clothes and carried my fall stuff on the bike to change into later. I strapped on my backpack that held my evening clothes and change of bike clothes, which would be hauled up for me in the baggage van, as well as putting on some lights. From my house it was only 4 miles to the start of the ride, of which the first third was downhill. It's worth noting that the wind chill going down a long steep hill had to be close to zero which I wasn't ready for this early in the year.

The ride started at 7 a.m. at the Fifth Third Ball Park, along the banks of the Grand River. I rode with Jim and Dennis Hammel, who a few of you met when he replaced me as a SAG on DALMAC two years ago, after my collar bone incident.

After 4 miles, the trail follows the Rogue River with scenic views from 2-3 hundred feet above the river which remind me of Appalachia. As you approach Rockford, you cross the Rogue over the old Railroad Trestle, a scenic dam, and then a pond with several geese and a pair of swans, as well as the old Wolverine World Wide Tannery, which they had started dismantling and will be gone by next year.

By 8:30, we reached the end of the first 16 paved miles at the first rest stop in Sand Lake. It was at this point I found out how well organized the ride was. As I came in, they asked for my rider number, where I was checked off and this was repeated at each stop. After a cup of coffee and some cookies, I took off.

The winds were reportedly 25 -35 mph out of the north and I was beginning to feel it. The heavier bike and lack of smooth rolling surface seemed to balance with Jim having more distance and more wind out in the open

since we would keep running into him at the rest stops and paved portion of the trail.

The start of the brief 1-mile paved portion at Howard City was a welcome site since I knew there was a nice restroom at the trail head there. I briefly considered switching to my fall weight coat, but decided against it. As the weekend turned out, I never did use it until the end.

The next stretch of unpaved trail after Howard City was in good shape considering it tends to be rutted from Amish Buggies and if wet, poses a bit of a challenge. After Morley, there's a bridge over old HWY 131 that I recognized as the Railroad Trestle that we bike under on the Quad Century. I realized a couple miles later that I was biking right behind Morley Stanwood High School which is often where the first night of the Quad is spent. As I was daydreaming about the DALMACs past, an Amish Wagon pulled onto the trail. Dennis had to quickly hit the breaks and swerve to avoid the first horse.

Another couple miles, we hit a flock of 20 turkeys, which may be the same flock we saw near the same spot the next day. The wooded area got pretty thick in that stretch, which provided us a welcome protection from the wind. There was one stretch that opened up enough to afford a view of the Muskegon River in the distance before plunging into the woods, downhill towards the river and into Big Rapids. The stretch of pavement south of town was out in the open and exposed but soon we found ourselves along a pretty stretch along the Muskegon River Rapids where lunch awaited us along the river. The Ruben Sandwich I ordered at registration was mighty tasty.

After remounting, we followed the river a couple miles before crossing it. Another few miles, we came to Paris where there was a fish hatchery and a Mecosta County park along the river where Dennis and I left the trail to see the replica of the Eiffel Tower. It looked like a nice spot for a Summer Tour stay since the trail was still paved and it was a large enough campground; although the bathrooms were locked for the season, so I can't vouch for them being adequate.

When we reached Reed City, there was a marker where the Pere Marquette Trail crossed. I realized I had been there before on DALMAC and hadn't realized that significance of the spot. Rather, it was a point where I was always confused as to where I was to go to stay on the WPT which seemed to be splitting.

We then went through a covered bridge over Hersey Creek and the end of the pavement again. The next stretch was out in the open where we could see Jim off to our left on old 131 until he turned left to go on the other side of the new 2-lane HWY 131, which appeared on our left. We followed it for several miles. This was the least scenic part of the trail. It occurred to me I had driven over there many times, not realizing the trail was right next to

me. I'm sure that stretch is hardly ever ridden so there probably wasn't anyone on the trail when I drove by.

We eventually entered the woods again. passing a pond where Dennis pointed out that a beaver dam, at one point, had washed out the trail. We went under a couple of short tunnels that went under the old highway along that stretch. The last tunnel was before Leroy, where we happily picked up the recently paved trail, as well as another well decked out rest stop. This was another spot where I had ridden before without realizing that the WPT was there. This was also where we met a bicyclist from Traverse City who'd come from Cadillac to check out the new pavement. He passed us with his fresh legs and light road bike, but Dennis and I felt the need to pick up the pace to keep up with him and hence the chat with him.

As we pulled into Cadillac, I realized we were routed off to our hotel before the trail actually ended. It didn't take any arm twisting to talk Jim and Dennis into going to the end before going to the hotel. Although this added a couple miles and a big hill, it was worth it, since in my mind, that was the point of the previous 90 miles.

A lot of people hit the pool and hot tub at the hotel, but I opted to head to the Mexican restaurant next door for an adult beverage and to watch the last half of the Michigan Football game. Eventually, everybody ended up over there. We all had dinner in the banquet room and talked about the routine for leaving the next day.

The next morning we left with frost on the ground and rode in the dark for the first half hour with our lights. Jim somehow got a half mile head start and I never did close the gap to his blinking red light until the first stop. The hot breakfast of pancakes, sausage, and hot coffee in Leroy were welcome, as was the tail wind, although it was half as strong as what we'd ridden into the previous day.

After another nice lunch in Big Rapids, including hot soup, we took off. At the final rest stop in Howard City, I break out my fall weight jacket and gloves. The final stretch of pavement was welcome to tired legs as well as the fact that it was down hill. As we pulled into Comstock Park, Dennis offered to give me a ride back to my house since it was on his way home. I had to admit I wasn't looking forward to going up hill with my backpack after 190 miles of trail riding, so I whimped out and took the ride.

Looking back at it, it worked out well that I couldn't ride prior to this past year. It would have been a more difficult ride before the 16 miles between Leroy and Cadillac had




