## TRI-COUNTY BICYCLE ASSOCIATION BOARD OF DIRECTORS MEETING MINUTES

June 5, 2012, Foster Community Center, Lansing, Michigan

**Present and constituting a quorum**: Roger Nelson, Steve Leiby, Wendell Proudfoot, Patricia Trudgen, Heidi Vanator, and Janet Weber. **Absent:** Steve Schuesler. **Others present**: TCBA Club members – Darryl Burris, Pete Derkos, Jeff Dillingham, Katie Donnelly, Bill Savage, and Mike Unsworth.

President R. Nelson called the meeting to order at 6:31 p.m. and presented the agenda, making additions as deemed necessary by the board members and other members present. J. Weber **MOTIONED** to approve the agenda as amended. S. Leiby seconded. Motion carried.

J. Weber presented the minutes for the May 1, 2012 meeting. P. Trudgen **MOTIONED** to accept the minutes as written. H. Vanator seconded. Motion carried without dissent.

W. Proudfoot presented the correspondence he picked up at the mailbox. He offered to those present, the magazines. He discussed how we received duplicates of several bicycle magazines. R. Nelson suggested the magazines be brought to the monthly meetings so other members who may be interested can take. S. Leiby also presented newsletters he received for anyone who may be interested. H. Vanator stated she spoke to Dick Allen and advised he was having a surgical procedure next week.

### **BOARD REPORTS:**

**PRESIDENT REPORT:** Roger indicated the Williamston Township Hall rides on Tuesdays and Thursdays, that the Scheidlers, who have led for many years, will be unable to lead rides for most of the summer. He is concerned that we may have too many locations for rides. He suggested a possible solution could be to have a few popular locations established and then have a list of volunteers to rotate the leading of the rides. No input from the board was provided, therefore, no action was taken.

VICE-PRESIDENT REPORT: No report.

**SECRETARY REPORT:** J. Weber stated she would be putting the Nominee Profile sheet in the next newsletter along with a small announcement for folks to consider running for Board positions next year. She indicated she would be unable to run for her current position next year.

**TREASURER'S REPORT:** S. Leiby presented the financials. He discussed the addition that showed a year-to-year comparison. Accounts are growing steadily. He highlighted that it was not unusual this time of year to have no income as stated in the reports. H. Vanator **MOTIONED** to approve the financials. W. Proudfoot seconded. Motion carried.

**EVENT DIRECTOR'S REPORT:** H. Vanator presented that things were rolling along well for this year's DALMAC. Current number of participants as of this date: 5 Up: 387; 5 day: 521; 4 East: 183; 4West: 554. She also reported the Buying Committee were trying to decide the color of flags to purchase for this year...orange, yellow, or pink? The consensus was for orange. She will have the buying committee purchase them. She further indicated she had set the date and location for the upcoming Committee Meeting and Crew. They will both be held at the Spartan Hall of Fame, the Committee members will be held on August 16, at 6 p.m.; the Crew will meet on the 23<sup>rd</sup> at 6:30 p.m.

**AT LARGE REPORTS:** P. Trudgen reported that she and Pat Harrington, who are working on the Crews for DALMAC, are much further along than ever. At this time, they have all positions filled and they have wait list in case someone has to cancel. She also stated that all incentive items were available at the last meeting, less level 1, which will not be available until August.

W. Proudfoot reported that he was still working with the local bike shops on developing an alternative for members to obtain future incentive items through them. It was his hope, if the 'bugs' can be worked out, this may be available for this year.

### **COMMITTEE REPORTS:**

**SUMMERTOUR:** Pete reported he had some things yet to do. He stated the 13<sup>th</sup> of June was the cutoff date. He has received a few cancellations, but nothing major to report at this time.

**NORTHWEST TOUR:** J. Dillingham reported that his committee met last night for a Crash meeting and stuffing. The Tour starts next Wednesday. He indicated Camp Ground is full this year, apparently due to people who missed out on registering for the Tour.

**DALMAC Fund:** S. Leiby reported that the presentations at the last membership meeting went well. One organization approved to receive a grant did not show, but will tell them they need to, before presenting the award letter.

**Safety & Education:** B. Savage reported he was trying to get an LCI class scheduled for Oct 5-7, since those dates do not conflict with an MSU home game. He indicated the class could use the parking lot at MSU Bikes on campus. He is still pursuing this class, however, he still needs a minimum of 8 to have the class.

**MEMBERSHIP:** W. Proudfoot reported that as of the beginning of the month, we have 1,047 members; about 741 memberships. K. Donnelly asked about the interpretation of 'public roster' as omitting folks from the monthly newsletter welcome article. We do not have a public roster. Katie expressed she feels it is a nice gesture to welcome new members by placing their name in the newsletter. After some discussion, it was agreed that placing the new members as a way to welcome them, without the city where they live, would be continued.

ADVOCACY: M. Unsworth reported several causes his Committee was working on. A complete Advocacy Report will be sub-

We discussed how we have some members who participate with this organization. The Board decided that we place the ad in the newsletter and charge the usual advertising cost of \$5.00.

We followed up with last month's discussion regarding the Healthy & Fit Expo. The board received the application along with the size of the space needed, which would cost \$480. P. Trudgeon **MOTIONED** that we participate in the Healthy & Fit Expo on 15 Sep 2012, and submit the \$480 to reserve the needed space. W. Proudfoot seconded the motion and it carried.

The Board discussed that we did not recognize Edie Belcher as the 2011 Ride Leader of the Year. After discussion, the Board decided we would obtain a gift certificate for a local restaurant to present to the awardee at the June membership meeting.

We received correspondence to participate in the1<sup>st</sup> Annual Bike Expo in Kalamazoo. The Board discussed this and decided since it was outside of the tri-county area we would not participate. W. Proudfoot will contact them to decline our participation.

We also received an invitation from the West Lansing Walmart about a house fair in which they wanted to know if someone could attend on June 23<sup>rd</sup> to discuss biking to seniors and pass out literature. We have no one available to participate. Roger will decline our involvement.

Sleeping Bear Dune climb will have a ribbon cutting ceremony on June 20<sup>th</sup>. This organization has been a recipient of several DALMAC Fund grants and as such continually invites us to participate in these events. J. Dillingham will check his schedule to see if he can attend.

    - 3. On July 6 WLNS Channel 6 broadcast an interview with Mike Unsworth about Operation Soft Serve
  - C. A meeting of non-motorized regional transportation stakeholders was held on June 20:
    - 1. Polly Kent, MDOT's statewide Complete Streets Coordinator talked about State Government's initiatives on infrastructure, Statewide Complete Streets policy Statewide long range transportation plan
    - 2. Media Awareness—Consultant Barb Lezott Miller and City Pulse's Andy Balaskovitz gave tips on creating buzz
    - 3. Brainstorming session on possible activities
- II. Recent developments:
