TRI-COUNTY BICYCLE ASSOCIATION BOARD OF DIRECTORS MEETING MINUTES

April 3, 2012, Foster Community Center, Lansing, Michigan

Present and constituting a quorum: Steve Schuesler, Wendell Proudfoot, Patricia Trudgen, Heidi Vanator, and Janet Weber. **Absent:** Roger Nelson and Steve Leiby. **Others present:** TCBA Club members - Mike Unsworth and Jeff Dillingham.

Vice-President Steve Schuesler called the meeting to order at 6:33 p.m. and presented the agenda. Mike Unsworth made a request to add the Advocacy Committee to the agenda. **MOTION** by J. Weber to accept the agenda with the inclusion of the Advocacy Committee. Pat Trudgen seconded the motion. Motion carried unanimously.

J. Weber presented the minutes for the March 6, 2012 meeting. S. Schuesler **motioned** to accept the minutes. H. Vanator seconded. Motion carried without dissent.

BOARD REPORTS:

VICE-PRESIDENT REPORT: S. Schuesler sent out the specifics to the board for the picnic. He requested J. Weber publish this information in the newsletter informing members the starting time would be noon and folks can sign up at the next two meetings. Steve also mentioned the outstanding job of Sue Cook who presented at last month's meeting.

SECRETARY REPORT: No report.

TREASURER'S REPORT: S. Leiby emailed the financial reports to the board members for their review since he was not going to be present for this meeting. **MOTION** was made by J. Weber to accept the reports as submitted. W. Proudfoot seconded. S. Schuesler abstained from the vote. Motioned carried.

EVENT DIRECTOR'S REPORT: H. Vanator stated that Deb Holcraft, chair of the T-Shirt ride, contacted her to advise that she was approached by a non-bicycle organization requesting to set up a booth at the annual event in June. After the board's discussion, they concluded they would maintain consistency with the TCBA policy not to promote non-bicycling events/organizations. H. Vanator reported things with DALMAC were going fine. She updated the board on the jersey stating Primal has the first sketch of the jersey; however, they did the jersey different from the submitted artwork. Additionally, the Buying Committee was still working with one school to get the logo for the jersey. The logo for the sweatshirt, T-shirt, hats will be as shown in the application book. P. Trudgen reported to date, the number (percentage) of registrants were: UP - 288 (46%); 5-Day - 398 (63%); East - 96 (17%); West - 442 (70%) for a total of 1,224 registered participants. She indicated they also need more volunteers, specifically, the 5-day route needs a SAG driver, while the UP route still needs volunteers for Bags & SAG.

AT LARGE REPORTS: P. Trudgen stated she ordered the booklets that were presented last month for children. They will be available at the May membership meeting where the topic of the meeting, in part, is the Poster Contest Winners. This will allow those present and the winners to receive a copy of the book.

W. Proudfoot presented the 2012 Incentives. He stated he was working to get more of the bike shops involved in allowing the members to order the incentive items from them. We want the shops who want to participate to recommend incentive items for various levels based on input

from the members who frequent the shop.

COMMITTEE REPORTS:

Advocacy Committee: M. Unsworth presented the board with the March Advocacy Committee monthly report summarizing the issues discussed. He requested the minutes be published in the newsletter. P. Trudgen **motioned** to accept the report for publishing. H. Vanator seconded. Motion carried without dissent.

Web Site and Membership: W. Proudfoot discussed with M. Unsworth regarding what the Advocacy Committee was looking for from the membership database. During the discussion, the Advocacy Committee was looking for email addresses. We do not currently maintain a comprehensive list of email addresses. Clarification was made that the Advocacy Committee was only looking for those addresses who want to receive updates on what the committee is doing. Wendell also requested this Committee and M. Unsworth be added to the Chainwheel Chatter as one of the contacts. Wendell also indicated a new page for this group would be added to the website. Development of this is also in the early stages. M. Unsworth indicated he was willing to be a member of the Web Site Committee. Wendell stated for the month of March we had a total of 41 new and renewed memberships. Wendell voiced a concern about the need for new/additional membership categories for organizations who want to be on the mailing list.

Ride Incentive & Club Jerseys: Wendell indicated was preparing to order the 2011 incentive items for levels 2-5. **MOTION** by S. Schuesler to accept the report. H. Vanator seconded. The motion carried without dissent.

Winter Party: **MOTION** was made by S. Schuesler that the holiday party be set for December 6th at Chisholm Hills. P. Trudgen seconded, and the motion carried without dissent.

OLD BUSINESS:

VIETH CONSULTING MEMBERSHIP DATA MANAGEMENT - Jeff Dillingham updated the board regarding the Vieth Consulting bid. He learned TCBA would own the data. There is going to be a training session on April 12, 2012 to learn how to manage databases. This is a free event put on by folks in the Lansing area. Jeff, M. Unsworth and W. Proudfoot will be attending this to make more determinations regarding Vieth. No further board action was required at this time.

U.S. CONSUMER PRODUCT RECALLS

WASHINGTON, D.C. - The U.S. Consumer Product Safety Commission, in cooperation with the firm named below, today announced a voluntary recall of the following consumer product. Consumers should stop using recalled products immediately unless otherwise instructed. It is illegal to resell or attempt to resell a recalled consumer product.

Name of Product: Salsa Minimalist bicycle racks. **Units:** About 1,100. **Manufactured in:** Taiwan.

Manufacturer: Salsa Cycles, a wholly-owned brand of Quality Bicycle Products Inc., of Bloomington, Minn.

Hazard: The L-shaped mounting straps used to attach the bicycle rack to the front of the bicycle can break and cause the rack to fall while the bicycle is in use, posing a fall hazard to the rider.

Incidents/Injuries: Salsa Cycles has received two reports of bicycle racks breaking at the mounting straps, resulting in minor injuries from falls.

Description: This recall involves all Salsa Minimalist bicycle racks sold after January 2011. The racks are made of tubular aluminum with a black or silver finish, and can be installed on either the front or rear of a bicycle. The recalled bicycle racks have steel mounting brackets, identified as straps, with a single hole in the center used to mount the strap to the bicycle fork. "Salsa" is printed on the side of the bicycle rack.

Sold by: Bicycle retail stores nationwide and on Internet retailers from January 2011 through March 2012 for about \$80.

Remedy: Consumers should immediately remove the recalled bicycle racks and contact an authorized Salsa dealer for inspection, re-mounting or refund.

Name of Product: Bicycle Brake Levers **Units:** About 600. **Manufactured in:** China.

Importer: Specialized Bicycle Components Inc., Morgan Hill, Calif.

Hazard: The adjuster cap and brake cable can slide out of position and make the brakes non-operational. This can cause a rider to lose control of the bicycle and crash.

Incidents/Injuries: Specialized is aware of one incident worldwide in which the rider lost the function of both brakes. The firm has received no reports of injury or property damage.

Description: The recalled products are Tektro TL-83 brake levers. TL-83 levers are designed exclusively for use with aerodynamic handlebars (aero bars) sold as original equipment on 2010 and 2011 S-Works Shiv bicycle frame modules and 2012 S-Works Shiv TT bicycle frame modules. They are also sold as aftermarket service parts for these modules. The levers are modified versions of the TL-720 brake lever. They are black aluminum and have a quick release slot at the top of the lever arm. Model number "TL-720" can be read on the side of the lever arm when braking action is applied.

Sold at: Authorized Specialized Bicycle Components retailers from April 2010 to February 2012. The bicycle frame modules sold for between \$5,500 and \$6,100. The brake levers sold for about \$80 as service parts.

Remedy: Consumers should immediately stop riding bicycle frame modules equipped with TL-83 brake levers and return the levers or modules to authorized Specialized Bicycle Components retailers for free replacement brake levers.

Name of Product: GT, Giant and Trek Bicycles with SR Suntour Suspension Forks. **Units:** About 17,000.

Manufacturer: SR Suntour, of Taiwan and Vancouver, Wash. **Manufactured in:** China.

Hazard: The suspension fork's internal support tubes can break and cause the rider to lose control, fall and crash.

Incidents/Injuries: SR Suntour has received 12 reports of incidents with the suspension forks, including two injuries involving a laceration and a chipped tooth.

Description: This recall involves the following GT, Giant and Trek bicycles with SR Suntour suspension forks. "SR Suntour" and the date code are printed on the back of the fork crown.

Sold at: Specialty bicycle stores nationwide from April 2011 through March 2012 for between \$400 and \$600.

Remedy: Consumers should stop using bicycles with these forks immediately and return the bicycles to any authorized GT, Giant or Trek dealer for a free repair.

Name of Product: 2010 through 2012 Model Year Bicycles

Units: About 4,100. **Manufactured in:** Taiwan

Importer: Public Bikes Inc. of San Francisco

Manufacturer: Wellgo Pedals Corp. Taiwan (pedals)

Hazard: The pedals can crack and break, posing a fall hazard to the rider.

Incidents/Injuries: Public Bikes has received 24 reports of pedals cracking. No injuries have been reported.

Description: This recall involves 18 models of women's and men's Public Bikes. The bicycles are various colors and sizes. "Public" or "Publicbikes.com" is printed on either the bicycle chain guard or the rear fender. The bicycles have a metal "badge" at the top of the down tube with a number stamped on it. Recalled badge numbers are 1-5843, 5845, 12560, 20743 and 20757. The "Apple" model, which has no badge, is also included. The word "Wellgo" is embossed on both the top and bottom of the pedals. All bicycles with Wellgo pedals are included in this recall.

Sold at: Public Bikes & Gear in San Francisco and other Public Bikes dealers in 16 states nationwide and publicbikes.com from April 2010 through January 2012 for between \$500 and \$1,250.

Remedy: Consumers should immediately stop riding the recalled bicycles and contact Public Bikes or an authorized Public Bikes dealer for free replacement pedals. The recalled pedals have a black spindle, the replacement pedal spindles are chrome.

Name of Product: Topeak Babyseat™ II Bicycle Carrier Seats. **Units:** About 40,000.

Manufactured in: Taiwan

Importer: Todson Inc., of North Attleboro, Mass.

Hazard: A child can place his or her fingers in the opening at the grab bar's hinge mechanism. When the consumer lifts the grab bar to remove the child from the seat, the child's fingertips can be caught in the hinge mechanism, posing a laceration and fingertip amputation hazard to the child.

Incidents/Injuries: The firm has received two reports of incidents including near amputations that resulted in stitches and a crushed finger.

Description: This recall involves Topeak Babyseat II bicycle carrier seats with model numbers TCS2100, TCS2101 and TCS2102. Model numbers are printed on the product's packaging. The gray, plastic Babyseats were sold in three styles: Babyseat, Babyseat with disc brake compatible rack and Babyseat with non-disc brake compatible rack. The racks are used to mount the seat to the bicycle. "Topeak" is embossed on the back of the seat and is also printed on a black foam protector that covers the grab bar. A red locking lever on the side of the blue grab bar locks the bar into place.

Sold at: J&B Imports, REI, Action and Hawley, independent bicycle dealers, distributors and other retail stores nationwide and online at REI.com from January 2009 through April 2012 for between \$140 and \$180.

Remedy: Consumers should immediately stop using the recalled carrier seats and contact Todson to receive a free hinge cover retrofit kit.
