September 4, 2012, Foster Community Center, Lansing, Michigan

Present and constituting a quorum: Roger Nelson, Steve Schuesler, Steve Leiby, Wendell Proudfoot, Patricia Trudgen, Heidi Vanator, and Janet Weber. **Others present:** TCBA Club members Doug and Diane Sherman, Dave Pierce, Katie Donnelly, and Mike Unsworth.

President R. Nelson called the meeting to order at 6:35 p.m. He presented the agenda. J. Weber **MOTIONED** to approve the agenda. P. Trudgen seconded. Motion carried.

R. Nelson went through the correspondence and presented it to the appropriate person.

BOARD REPORTS:

PRESIDENT REPORT: No report.

VICE-PRESIDENT REPORT: S. Schuesler reported he is making progress on the holiday party. He has a committee lined up to help him with the event. Final arrangements will probably be made prior to the Sep membership meeting. S. Schuesler spoke with Diane Sherman a few months back who indicated her husband Doug Sherman was interested in taking this over since S. Schuesler would like to step down. Coordination between Steve and Doug will take place to insure the mileage forms are sent to the correct address. There may be a potential software problem since Doug uses an Apple computer, so the purchase of a new computer with appropriate software for Doug to do this, is necessary. S. Schuesler **MOTIONED** that Doug Sherman be named the Ride Mileage Keeper and make the necessary changes, and if necessary, purchase a computer and software to manage the program. Discussion involved obtaining the costs of the computer and software for this and bring them to the next meeting. W. Proudfoot will obtain the necessary equipment for Doug to use for managing the Ride Mileage program. J. Weber seconded. Motion carried.

SECRETARY REPORT: H. Vanator presented the minutes for last month's meeting, in the absence of J. Weber. S. Schuesler **MOTIONED** to approve the minutes. P. Trudgen seconded. Motion carried. J. Weber indicated she would not be present for the Sep membership meeting and asked if someone could take the newsletters to the meeting. In addition, any nomination profiles received should be collected by that meeting and brought to the next meeting unless an election is conducted during the September meeting.

TREASURER'S REPORT: S. Leiby presented the Balance Sheet, Profit & Loss (3-Year Comparison), and other financial reports. No DALMAC Fund payments were made during the month of August. Banners were purchased and paid with the cost for them reflected in the financials. The check for Albart's Storage location still has not cleared. H. Vanator **MOTIONED** to approve the financials. W. Proudfoot seconded. Motion carried.

EVENT DIRECTOR'S REPORT: H. Vanator reported DALMAC was a success and fun! There was a report of an accident involving a SAG driver and a private vehicle (non-DALMAC rider), as well as a bicycle. H. Vanator asked the bicycle repair bill be submitted to her for payment. H. Vanator will contact the Ride Leader and have him contact Dwayne Scheidler, our insurance agent, for the other damages to see if our policy covers the costs. She discussed some of the rider comments received, which were positive, as well as some suggested improvements by some riders. She also updated the board on the status of one rider who was injured in an automobile accident during DALMAC, who fortunately, is recovering well. S. Schuesler requested we maintain contact with the Sherriff's office to see where they stand regarding prosecution. S. Leiby stated there was a video U-tube video with Dick Allen (Google for: DALMAC Dick Allen, u-tube). Perhaps we should get a professional video done with him in it. Dick Allen is interested in doing this and he suggested we obtain a few other riders to par-take in the video to market and advertise DALMAC. Future Media would charge \$1,500 per video minute. H. Vanator thinks this is a great idea

and suggested we work to make it happen as soon as possible. S. Leiby **MOTIONED** we create a video featuring Dick Allen speaking about the startup of DALMAC setting cost up to \$40,000 for this project. H. Vanator seconded the motion. Motion carried.

AT LARGE REPORTS: W. Proudfoot discussed the Ride Incentives. He discussed the purchase of the jackets. Committee decided to purchase them from LL Bean for members to try on. Most recipients have tried them on with their choice of colors. The committee needs to make a decision regarding the logo (silk screening or embroidery) placed on the jackets. Distribution of other items have been made at previous meetings, as well as at the DALMAC registration.

P. Trudgen indicated there is a meeting scheduled for 6:30 p.m. on September 24th at Foster to collect suggested improvement to DALMAC. If anyone has any information, please submit to either her or Heidi.

COMMITTEE REPORTS:

ADVOCACY COMMITTEE: M. Unsworth presented the board with letters about the Amtrak Station for approval. S. Schuesler **MOTIONED** to approve the letters as presented. H. Vanator seconded. Motion carried. M. Unsworth will print the letters for R. Nelson's signature. Mike also presented the Advocacy Committee report from their meeting they held last month.

SAFETY & EDUCATION: S. Leiby mentioned there will be an LCI class October 5-7. Bill Savage had asked if the club would be willing to reimburse ½ the cost for TCBA members who successfully complete the class. S. Leiby discussed the prerequisites of becoming an instructor. H. Vanator **MOTIONED** the club reimburse TCBA members who successfully complete the class for ½ the cost of the instructor course. J. Weber seconded the motion. Motion carried,

MEMBERSHIP: W. Proudfoot reported the board had discussed setting up an on-line registration. PayPal arrangements have not been established as of yet. He believes he will soon have a link to the Wild Apricot site for membership registrations as well as an invoice for membership dues. Lake Trust signatures need to be obtained by the appropriate Board Members tonight.

As of October 1, 2012, we have 1010 Individual and Family members.

- I. Advocacy Committee actions:
 - A. Bike Parking update
 1. Mike & Steve promised that they review the Bicycle Parking Guidelines drafted by the Association of Pedestrian & Bicycle Professionals and incorporate them into the guidelines for TCBA-funded bike racks
 2. Since bike parking is a key component of a Bike Friendly Business program, we began preliminary discussions on drafting criteria and guidelines that would be specific for the Tri-County Area.
 3. Operation Soft Serve is hibernating for the winter. We intend to re-launch it in the spring
 - B. Greater Frandor Area developments:
 1. A Community Conversation on the future of the Red Cedar Golf course is planned for Saturday, October 13, from 10am to 2 pm at the Foster Community Center. Advocacy Committee members are participating in the planning and running of this meeting.
 2. US127/Frandor—Last summer’s construction on US 127 brought out a lot of simmering frustrations from Lansing residents west of Howard Street. They have many concerns about accessing Frandor from their neighborhood.
 3. Thus, the October 24 Quarterly Active Transportation meeting at the Foster Community Center will be devoted to transportation issues in the Greater Frandor area
 - C. The Advocacy Committee is running the October 14 Saginaw Street Ride in celebration of the completion of the Saginaw Street Bridge over the Grand River and the installation of a “buffered” bike lane on Saginaw Street.
 - D. Regional Infrastructure Issues – We discussed developments at MSU, the Lodges of East Lansing, and Meridian Township’s passing a Complete Streets ordinance
- II. The Michigan Department of Transportation’s recently had public workshops/discussions on MDOT’s planning process and 2013 construction projects on US127 and M43/Grand River in East Lansing. Committee members attended these meetings and are analyzing their impact on non-motorized transportation. We have invited MDOT officials to our October 17 meeting for a dialogue on some of our issues.

City of Lansing Activities

- Waverly pathway opens to traffic. Final completion (landscaping, fencing, and final clean up) scheduled for mid-October.
- Saginaw Bridge. Completion, including bike lanes, scheduled for early October. Ribbon cutting including bike ride/parade scheduled for October 14th.
- Design started on Mt. Hope Bridge that would extend the bike lanes currently ending at Aurelius to Lindbergh. Construction scheduled for 2013
- Design close to completion for Holmes Road (Washington to Cedar) that would convert this from 4 to 3 lanes with bike lanes. Construction scheduled for 2013.
- Design underway for South Lansing Pathway, Segment 1: Cavanaugh to Pennsylvania. Construction anticipated for 2013, assuming CMAQ funding.

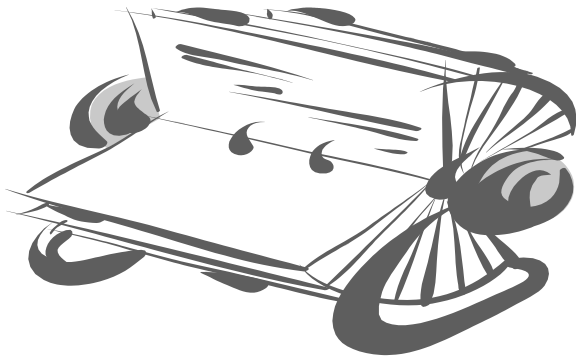
