BIKE PARKING PROGRAM

Tri-County Bicycle Association is proud to announce the completion of its very first Bike Parking program! At the June 4, 2013 board meeting, it was agreed upon to fully fund a Boy Scout Eagle Project in Olivet, Michigan. Boy Scout Jacob Vanator, who had ridden the DALMAC 6 times, presented the need for bike parking in his hometown which currently had none. In just 30 short days, he had petitioned every business in the downtown area, the local post office, BP gas station and the local Dollar General to get the approval and support. He also consulted with the local government, Olivet College and secured a contractor who would oversee the project.

Once Jacob had his funding, he made a call to Skip Dowding, local owner of Dowding Tool. Skip readily took on the project to have the bike racks made, but decided to subcontract an Olivet business, Masterbilt Products Corporation, for the actual manufacturing of the racks. After the heavy duty racks were made, Dowding hauled them to Flint, Michigan for a 3 step powder coating.

Once the 24 completed racks arrived in Olivet, the scouts and contractor, Danny LaPoint, got started. After more than 100 man hours of work, all the racks were installed and Olivet is now a more bike friendly community with adequate bike parking throughout its town. To celebrate the completion of his Eagle Scout project, Jacob held a small dedication ceremony on Sunday, October 13, 2014. Several TCBA members, Boy Scouts, friends and family were on hand to celebrate with the young scout.

To help fund this bike parking project, TCBA Treasurer Steve Leiby suggested using the funds from three separate memorial funds and honor those TCBA members who had passed away. Jacob dedicated his Eagle Scout Bike Parking Project to: Jim French, Donovan Riley and Will Rodriguez. A plaque will be on display at Olivet City Hall. You can only imagine how blessed Jacob was when Sue Riley, widow of Donovan Riley, came to celebrate! She told the scout that Donovan was smiling down at this project! He had been quite active with the Boy Scouts of America!!

Jacob would like to express his deepest thanks to all the members of TCBA and especially the Board for their support. He has taken on a new mantra (after hearing it from Mike Egan) "Keep the wind at your back!"



DALMAC FROM BEHIND THE WHEEL

Since in recent months I've spent less time riding my bike and exercising, and more time watching TV and eating Doritos and cheese corn, I chose not to ride the 2013 DALMAC. But with summer, I felt a sudden gust of guilt, and decided I should try to help out in some way. Seeing in the *Chainwheel Chatter* that the DALMAC staff needed baggage truck drivers, I remembered the early 1970s, when I drove trucks - semis, that is. Living in Denver, I spent about a year driving city deliveries and over-the-road, where I traveled as far west as Phoenix, and as far east as the Pocono Mountains in eastern Pennsylvania. If I could manage a semi with between 10 and 16 gears, I figured I could drive one of the large straight trucks DALMAC uses to haul rider bags.

I contacted TCBA and was directed to Pat Trudgen, Club President and Leader of the 4-Day West and Quad-Century rides, now combined. She got my info, had me attend a dinner planning meeting of all DALMAC volunteers, and I showed up early on DALMAC's Thursday morning start. There I met lead driver Ron Mason, and another first-time driver, Leon Wilhelm. I was relieved to find that my truck, an older International, had automatic transmission, so my rusty shifting skills wouldn't be tested. Leon drove a GMC and Ron a Ford, so we covered most of the bases. With my truck mostly full, I loaded my bags and bike, as I intended to ride a little each day.

Riders were mostly punctual, and we left the MSU Pavilion a little after 9 a.m., with Ron leading, me following, Leon next, and Pat sweeping behind in her RV. On reaching Vestaburg, Leon and I connected our water station hose to the school and set up the cell phone charging stations in the school, then helped Ron and Pat finish setting up the sheltered "headquarters" table in front of her RV. We drivers performed other tasks at each campsite, like clicking counters in food lines and helping with situations as they arose. Then it was the daily wait until the first riders arrived, time that I used to find a prime spot to put up my tent. When a few arrived, we told them we'd wait to unload until more came to do the job. But the riders, mostly on the Quad-Century, would insist on going right away. I was impressed at how they took to it, working with a team-like effort till the job was done. They proved to be even more ambitious over the next three days, unloading quickly as we drivers edged the trucks forward.

Tiny Vestaburg, with only one restaurant and a gas station/convenience store nearly a mile out of town, turned out to a great camping stop. The school was very clean, the showers warm all day, and the food was good. The staff and community made us feel as welcome as I've ever experienced, many of us agreeing it was a top DALMAC destination.

As I would for the next two days, I changed to biking duds and rode the course a few miles in reverse, greeting approaching riders with "Welcome to Greater Vestaburg!" or "You're entering Vestaburg's outer suburbs!" As a ride staff member, I felt a responsibility to making DALMAC fun.

That next morning I seemed to be brain dead at 7:00 AM, as I was finishing up my breakfast when informed my truck needed to be opened for loading! I would not make the mistake again.

On this second morning, and the two to follow, I found that riders were STILL asking to be reassured that their bags were headed for the right destination, Lake City on Friday, Boyne City on Saturday, and even Mackinaw on Sunday. So I decided that this was another opportunity to make DALMAC "fun." I gave replies like "Don't worry, your bags will be waiting for you in Cheboygan." Or "Sault Ste. Marie." Or "Negaunee." Most laughed when they realized that there was only one place all three trucks would go that day. But some looked startled and confused till they realized they were being had. THEN they'd sheepishly laugh.

When riders were mostly on their way, we gathered up supplies and loaded them into Ron's truck, and helped pick up around the school and grounds, which never amounted to much. What amazed us most was how hundreds of us would camp overnight, and would be gone early the next morning with little evidence we had ever been there. Made me feel proud to be a real biker, one on a bicycle.

I got along especially well with the other "rookie" driver, Leon. From the first day we were telling each other stories, mostly true, and laughing. At Boyne City, his wife Nancy joined us and rolled her eyes as she verified his

stories. I especially liked his tale about his first DALMAC in 2000:

Hearing fellow workers at GM brag about doing DALMAC, he upped his mileage, hoping to manage four days on a bike in late August. Adding greatly to his burden was his bike, one of the knobby-tired mountain variety which weighed about 30 pounds. Also adding to his woes was the literal way he viewed the DALMAC packing list's "On Bike" items. He chose to carry EVERY item on it, including the likes of sunglasses, sunscreen and chap stick, a first aid kit, aspirin, talcum powder, a camera and film, maps, headbands, warm gloves, a poncho, a light jacket, a windbreaker, tights, arm and leg warmers, a bike cap, Kleenex, extra sox, a towel and swimsuit, as well as a bike lock. Leon found that his bike was so heavy that the kickstand couldn't hold it upright, so he leaned it against fences where he camped.

He had struggled with his monstrous mount with its bugling packs for two days when he encountered an "old pro" biker named Jack, likely in his sixties or seventies. The old guy looked at Leon's bike and asked, "Are you training for a European tour?" Puzzled, Leon said, "No." The old guy asked, "Are you planning to ride coast to coast?" Again Leon said "No." "Well," said Jack from his tiny, lightweight road bike with one small pack, "Training for DALMAC ended two days ago, so get all that crap off your bike." It got a bit easier after that, but he had one more learning opportunity.

Taking the "In Bag" part of the DALMAC packing list literally also, he had brought an identical pair of shoes (tennis shoes to fit in the old-fashioned stirrups on his bike pedals) in one of his bags for the "Spare Biking Shoes" requirement. By Charlevoix he realized he didn't really need them, so he handed one pair to Nancy, who put them in her car before heading for a motel in Gaylord, saying she'd see him in Mackinaw City the next afternoon. Later, when he laid out his clothes for the last day, he saw that he had TWO LEFT SHOES. Nancy was long gone, he had no cell phone yet, and it was near 8 PM. Luckily he found a store open at that late hour, and bought himself another pair of tennis shoes. Cost him \$75 and an hour of aggravation.

What impressed me the most about serving as a DALMAC baggage driver was the appreciation shown by the riders. When our efforts were recognized at the Saturday evening meeting, it was nice. But the rest of it was what was special. As we moved about the campgrounds or stood in the food lines, riders for four days recognized us, thanked us, and told us we were needed and appreciated.

My next DALMAC is likely to be on a bike, but another, behind the wheel of a truck, is not far down the road.

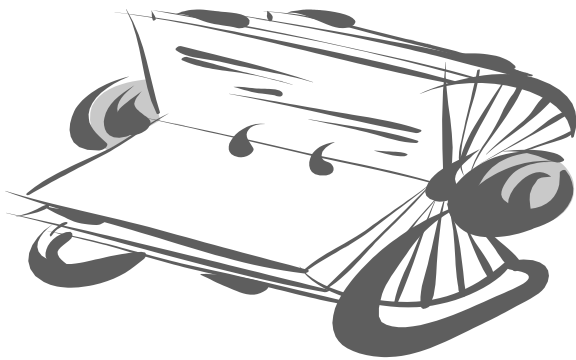
