**TRI-COUNTY BICYCLE ASSOCIATION BOARD OF DIRECTORS MEETING MINUTES
December 4, 2012, Foster Community Center, Lansing, Michigan**

Present and constituting a quorum: Roger Nelson, Steve Schuesler, Steve Leiby, Wendell Proudfoot, Patricia Trudgen, Heidi Vanator, and Janet Weber. **Others present:** TCBA Club members Pete Derkos, Jeff Dillingham, Katie Donnelly, Adreah Saxton, Dwayne Scheidler and Joel Wickham.

President R. Nelson called the meeting to order at 6:33 p.m. He presented the agenda.

BOARD REPORTS:

PRESIDENT REPORT: No Report

VICE-PRESIDENT REPORT: S. Schuesler reported that 76 folks registered for the Holiday Party. He indicated the amount per person so Steve L. can have payment available for Thursday. The Barons of Brass will provide entertainment.

SECRETARY REPORT: J. Weber presented the minutes from last month's meeting that P. Trudgen took in her absence. After a discussion to make a few corrections, S. Schuesler motioned to accept the minutes as corrected. W. Proudfoot seconded. Motion carried.

TREASURER'S REPORT: S. Leiby presented the financial reports. He indicated he discussed credit card/PayPal fees with the tax preparer and it was recommended they be included in the expenses of the report. He informed us that we consider the value of using these methods and if they are worth it to continue for the fees being assessed. J. Weber motioned to approve the financial report. P. Trudgen seconded. Motion carried. Steve then presented the draft budget for 2013. He pointed out that he put \$0 for the T-Shirt Ride since, at this time we do not have a Leader. He recommended discussion of giving LMB and LAB \$1,000 each, which we did in 2011. The Board agreed the amount be paid in 2012 as well. He has penciled these amounts in the 2013 draft, along with costs for Grant and Community Donations for the DALMAC fund of \$50,000 and bicycle parking at \$30,000. The bicycle parking is a proposal for placing bicycle racks in various areas throughout the community. At this time, there is no definite plan, but the Advocacy Committee is working on language to define what constitutes an eligible bicycle rack to receive the grant. This is the first draft, so adjustments will be made for the second draft. He further recommended the finalization of the 2013 budget be left for the incoming board members. It was suggested the budget for the Poster Contest be reduced because they had a special circumstance this year that is not expected to be an annual expense. If the circumstance presents itself again, the Poster Contest Committee will come before the board requesting any needed increase. No motion is needed at this time.

EVENT DIRECTOR'S REPORT: H. Vanator reported that they are working on a legacy video of Dick Allen along with several other individuals who were among the initial crew who established DALMAC. She and Steve L. explained the cumbersome process of viewing what has been taped and determining which segments should be used in the final production. Filming is still in progress, so there is no date established for the final product. She provided a summary of the recent National Bicycle Touring Network meeting she and several others attended in Denver.

AT LARGE REPORTS: W. Proudfoot indicated there were very few calls to the TUBES line.

COMMITTEE REPORTS:

RIDE INCENTIVE & CLUB JERSEYS: W. Proudfoot reported that all jacket incentive items have been distributed. Remaining items will be made available to sell at the next membership meeting. He indicated he is looking to have a 'store' on the website as a tool for members to purchase items they want as opposed to taking orders and bringing things to meetings. He summarized what the committee has determined for the various levels. The committee has made contact to local vendors for the issuance of the incentive items. S. Schuesler motioned to approve the Incentive Committees recommendations with regard to using the local vendors. H. Vanator seconded. Motion carried.

SUMMERTOUR: P. Derkos reported on the 2012 SummerTour. Report included location, routes, number of participants, volunteers, and costs. He also presented the 2013 SummerTour proposal requesting authorization to hold the event. There have been a few changes in some of the volunteers and their responsibilities for this coming ride. Route is in the east side of the State. Locations and routes have been established with a few more obligations to be made in the upcoming committee meetings. Registration will begin in February, as it has been done in the past. S. Leiby moved to approve the 2013 SummerTour as planned. W. Proudfoot seconded. P. Trudgen requested the board be provided an official proposal to review versus him just reading his proposal. Motion carried with one nay.

NORTHWEST TOUR: J. Dillingham submitted his 2013 proposal to conduct the NW Tour. The committee increased the number of participants to 300 and raised the cost to \$150. Proposal included projected income, expenses, volunteers and their roles, reward system for volunteers, and recommended disposition for surplus is still to be determined. S. Leiby moved we accept the

2013 proposal. P. Trudgen seconded. Motion carried. Jeff also requested the board authorize the NW Tour to donate \$2,500 to the Sleeping Bear Heritage Trail from the surplus earned in past events. S. Schuesler motioned we authorize the NW Tour Committee donate \$2,500 to this. J. Weber seconded. Motion carried. H. Vanator recommended the donation be from TCBA and NW Tour.

T-SHIRT RIDE: No report because we do not have someone to lead this at this time. S. Schuesler said he will lead this ride. H. Vanator motioned we approve the T-Shirt Ride for 2013. J. Weber seconded. Motion carried.

WOMEN ON WHEELS RIDE: Adreah S. reported on the 2012 ride and requested the board authorize the ride for 2013. Prior to continuing, she requested the board's approval for her to serve as both leader and registrar. She requested the applications be mailed to the regular TCBA address. She also requested approval to have a standard jersey available in a pink/fuchsia color without a year so it could be used from year to year. S. Leiby moved to authorize the 2013 WOW Ride and allow Adreah serve in the capacities she indicated. S. Schuesler seconded. Motion carried.

DALMAC FUND: S. Leiby reported on his discussions with CATA regarding the bike parking loops at various stops. He presented a letter from the Lansing Public Service Department regarding transportation improvement program amendments stating the city has been moving forward. S. Leiby presented an email he received requesting Bob Lovell be permitted to represent TCBA at the National Bike Summit in Virginia. He further motioned that Bob Lovell be approved to attend the summit. H. Vanator seconded. Motion carried.

MEMBERSHIP: W. Proudfoot reported 19 renewals and several have used PayPal.

CHAINWHEEL CHATTER: J. Weber reported that since there will be no membership meeting this month, she will need to make arrangements for delivery in December of the next issue to the various distribution sites. She also informed the board that she would not be available in January to pickup the newsletters and take them to the membership meeting that month. She will need someone else to do that in her absence. S. Schuesler indicated he would be willing to work with her on both issues.

WEBSITE: W. Proudfoot reported several members registered for the Holiday party, with little to no difficulty. There were a few who did incur problems. Although the method for registration wasn't perfect, it did work for the majority of registrants. He further reported that he would be working with Deb Holdcraft-Bach so she can receive the emails for DALMAC registrations.

OLD BUSINESS:

Insurance: Dwayne Scheidler presented the board with the costs of the insurance renewal policies for 2013. Cost increased \$175 for the year. J. Weber motioned to approve the renewal. S. Schuesler seconded. Motion carried.

Ride Mileage Problems: Pete D. mentioned that one of the SummerTour participants was not credited with his mileage. W. Proudfoot said one of the sign-up sheets was lost, so several people may have this problem. The mileage will be credited as members tell us it's missing. W. Proudfoot reported there have been several challenges with the ride mileage database. S. Schuesler volunteered and will enter the remaining ride data for 2012, so that will be taken care of.

NEW BUSINESS:

Poster Contest: K. Donnelly submitted a projection of costs for the Poster Contest for 2013, and requested the Board approve the club hold the contest again. P. Trudgen motioned the approval of the Poster Contest for 2013 at a cost not to exceed \$2,200. H. Vanator seconded. Motion carried.

J. Weber **MOTIONED** to adjourn. H. Vanator seconded. Motion carried.

R. Nelson adjourned the meeting at 8:26 p.m.

RIDE MILEAGE INCENTIVES FOR 2012

The 2012 Ride Year ended on November 30, 2012 (it runs from Dec 1 to Nov 30). We had 349 riders whose miles were recorded by Nov 15, and of those we have the following statistics:

More detail about each item, and the bike shops will be available on the web site. We expect to send you a letter saying that you are eligible for a Level X ride incentive. With the letter will be a form you can return indicating which Level X or below item you have selected. The ride incentive committee will assemble a purchase order to send to each bike shop. The purchase order will have your name on it so the bike shop can assure the item is going to the correct person. When you give them your Ride Incentive Letter, they will give you your incentive award item. .

U.S. CONSUMER PRODUCT SAFETY COMMISSION

WASHINGTON, D.C. - The U.S. Consumer Product Safety Commission, in cooperation with the firm named below, today announced a voluntary recall of the following consumer product. Consumers should stop using recalled products immediately unless otherwise instructed. It is illegal to resell or attempt to resell a recalled consumer product.

Name of Product: Izoard XP Bicycles

Units: About 200

Importer: Wilier Triestina USA LLC, of Atlanta, Ga.

Hazard: The bicycle fork's steerer tube can break while in use, posing a fall hazard.

Incidents/Injuries: None reported

Description: This recall involves Wilier Triestina model Izoard XP bicycles or framesets that were sold with carbon/alloy forks with serial numbers between LH0001 and LH4000. The serial number is located on the steerer tube of the fork, around six inches from the crown. Bicycles purchased before January 2012 are not included in this recall.

Sold at: Bicycle retailers nationwide from January 2012 through October 2012 for about \$2,600 for the bicycle.

Manufactured in: China

Remedy: Consumers should stop using the recalled bicycles immediately and have an authorized Wilier bicycle dealer check for the serial number on the fork and, if it is included in the recall, the dealer will install a new Izoard replacement fork at no charge.

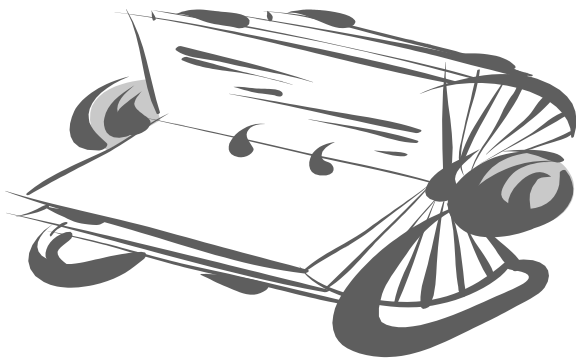
