Motion made by Pat T for Janet Weber as the volunteer of the year. Steve L seconded the motion. Motion carried.

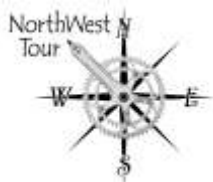
Steve S. made a motion to adjourn at 8:15 p.m. Seconded by Pat T. Motion carried.

## RIDE MILEAGE INCENTIVES FOR 2012

The 2012 Ride Year ended on November 30, 2012 (it runs from Dec 1 to Nov 30). We had 349 riders whose miles were recorded by Nov 15, and of those we have the following statistics:

### Incentives

More detail about each item, and the bike shops will be available on the web site. We expect to send you a letter saying that you are eligible for a Level X ride incentive. With the letter will be a form you can return indicating which Level X or below item you have selected. The ride incentive committee will assemble a purchase order to send to each bike shop. The purchase order will have your name on it so the bike shop can assure the item is going to the correct person. When you give them your Ride Incentive Letter, they will give you your incentive award item. .

## U.S. CONSUMER PRODUCT SAFETY COMMISSION

WASHINGTON, D.C. - The U.S. Consumer Product Safety Commission, in cooperation with the firm named below, today announced a voluntary recall of the following consumer product. Consumers should stop using recalled products immediately unless otherwise instructed. It is illegal to resell or attempt to resell a recalled consumer product.

**Name of Product:** Tikit Folding Bicycles

**Units:** About 3,800

**Manufacturer:** Green Gear Cycling Inc., dba Bike Friday, of Eugene, Ore.

**Hazard:** The tikit bike's handlebar stem can break and cause the rider to lose control, posing a fall hazard to the consumer.

**Incidents/Injuries:** The firm has received six reports of breaking handlebar stems, resulting in two reports of injuries including scrapes, bruises and a head laceration that required stitches.

**Description:** This recall involves all models of tikit brand folding bicycles. The 16-inch wheel custom bicycles were sold in various colors. The Bike Friday tikit brand decal is affixed to the bike frame.

**Sold by:** Bike Friday direct and dealers nationwide from January 2007 through September 2012 for between \$900 and \$5,000.

**Manufactured in:** U.S.A.

**Remedy:** Consumers should immediately stop riding the bicycle and contact Bike Friday to schedule a free repair.

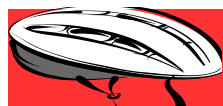

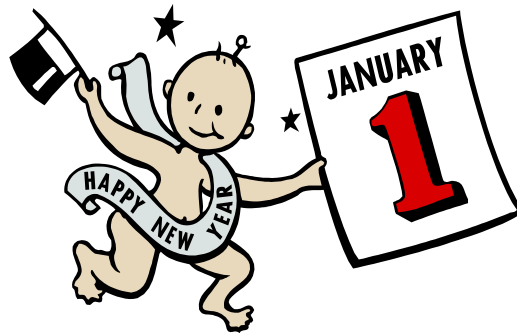

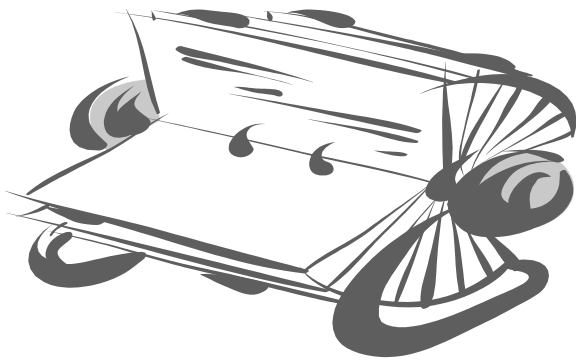
