## TRI-COUNTY BICYCLE ASSOCIATION BOARD OF DIRECTORS MEETING MINUTES

July 1, 2014, Foster Community Center, Lansing, Michigan

President Darryl Burris called the meeting to order at 6:37 PM. Only 4 directors were present. Patrick Baughan, Steve Leiby, and Joel Wickham were absent. Other members present were Mike Unsworth, David Pierce, and Wendell Proudfoot. Meeting agenda and June minutes were approved as written.

Correspondence: All that was received was reviewed and discussed. Darryl Burris mentioned 3 Rides he had received information about; Mountains to Sea, in North Carolina; A Ride from the Paw Paw, Michigan area, and Peckham Vocational Industries ride on 7-19-14 (same date as WOW).

### Board Reports:

**Presidents:** Darryl Burris talked in New Business about the Ride Leader Sheets

**Vice President:** Bill Smith reported on upcoming meeting programs and speakers. Holiday Party for TCBA will be on Thursday, December, 4, 2014. Bill also discussed the application by the Pump House in East Lansing, requesting Bike Racks. Motion was made to approve a budget of \$200 for these racks contingent upon Steve Leiby and/or Bill Smith's approval.

**Secretary:** no report.

**Treasurer:** Darryl Burris submitted the financial report and a motion passed to approve as written.

**Events Director:** Pat Trudgen reported that DALMAC exceeded last year's rider numbers, and is at 1669 registered riders. Reminder that the time to purchase clothing has ended, and that registration cut off is the end of July.

**At Large Directors:** Patrick Kelley reported that his ride posting proposal using social media had some member input. An e-mail was read that was sent to Bill Smith for the Board's consideration, and Darryl reported a few verbal comments that he has heard from members. Pat Trudgen recommended that this proposal be sent to the Chain Wheel Chatter for August 2014.

**Membership:** Wendell Proudfoot talked about the Traverse City bike club and their web calendar for posting rides and the estimated cost for TCBA to do this would be around \$3000/year

**Advocacy Committee:** Mike Unsworth submitted reports U.S. Housing & Urban Development work plan for Non-Motorized Transportation; 2015 National Bike Week; Poorly located road construction signs (usually in bike lanes and on sidewalks) on MDOT projects.

**Old Business:** No activity on the DALMAC agreement with Dick Allen. Patricia Trudgen and Pat Harrington are volunteering their time to go to Peckham Vocational Industries to help fit 30+ bike helmets. Darryl Burris presented a draft of the new Ride Sign-in Sheets that will have pre-paid postage on them. A motion to approve the changes and proceed with this and for the costs of \$600 passed. The Michigan Economic Impact Survey was discussed. A link to the Michigan Economic Impact Survey has not yet included in a DALMAC rider E-Mail. Steve Leiby was asked to get with Wendell Proudfoot to ensure coordination with DALMAC riders.

**New Business:** Discussion regarding the Capital Area Health Alliance's, Capital Area Parks and Trails Brochure, sponsorship by TCBA, for \$500. A motion to allow Steve Leiby a budget of \$500.00 for this venture passed.

### U.S. Housing & Urban Development work plan for Non-Motorized Transportation

Nancy Krupiarz and Steve Leiby are compiling a master map which will be digitized by the Tri-County Regional Planning Commission (TCRPC). This map will be used by TCRPC to be integrated in a forthcoming Master Plan and TCBA for print and online maps

### 2015 National Bike Week

The Committee discussed ways on enlisting public officials to participate in local events.

### Poorly located road construction signs (usually in bike lanes and on sidewalks) on MDOT projects

The committee had a detailed discussion about the inability of contractors to follow MDOT guidelines for sign placement and for MDOT to enforce them. It should be fairly straightforward since MDOT is supposed to inspect a worksite before authorizing payments. The committee is working on a letter of concern to send to MDOT.

## TCBA RIDE CHANGES

Part of "The Mission" for the Tri County Bike Association (TCBA) is to get people to ride their bikes together, safely. The TCBA Board is considering ways (in addition to the current way to post rides) in which the Called-in-Rides could more quickly be updated given newer technology available. Currently, the Ride Line is updated twice per week in the busier riding months, and once a week during the late fall, winter and early spring. We are wondering if there could be a way to allow rides to be posted, on some type of public form (TCBA Facebook page; Google Calendar?) that might allow riders to be able access rides more quickly. For instance, when Michigan weather allows, or perhaps weather interferes with a "posted" ride and the weather improves later in the day, someone may "post" a ride, at least 2 hours prior, that would count toward the Club Incentive, ride miles, (but no leader points), on this "public" forum. These rides would still need to comply with many of the other Ride Incentive guidelines, please refer to those; <http://www.biketcba.org/leaders/RideLeaderInfo.pdf>

We are considering counting miles for a TCBA ride of at least 4, or more TCBA riders who would utilize this type of posted ride. What are the pros/cons to this concept? Please post your ideas/thoughts for us to consider. Here are some questions to consider, or add your own:

- Would you utilize this type of service if offered to post or find rides?
- How many riders would you like to see as the minimum for this type of "posted ride"?
- What would be your minimum time be for "posting" a ride like this before a ride would start?
- How do make sure that traditionally posted rides are not impacted by these "impromptu posted" rides?

# RIBBON CUTTING CEREMONIES

TART Trails of Traverse City held the ribbon cutting ceremony for the Empire to Dune Climb phase of the Sleeping Bear Heritage Trail. Jeff Dillingham and I represented TCBA. TART Trails has raised an impressive eight million dollars to build the trail, six million public and 2 million private. TCBA has contributed \$35,000 through the DALMAC Fund and \$5,000 from NorthWest Tour. Consequently, TCBA is listed twice on the donor panels.

The trail now stretches from Empire to Glen Arbor. The next trail section will be built next year.

## 2014 DALMAC FUND GRANT AWARDS

The Tri-County Bicycle Association awarded \$80,300 in DALMAC Fund grants in 2014. The total DALMAC Fund grants awarded is \$1,234,981. In addition, TCBA awarded \$6,500 in TCBA general funds. The following identifies the awardees and amounts awarded.

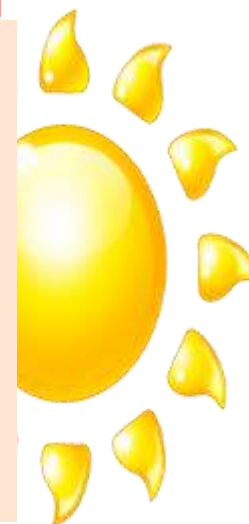

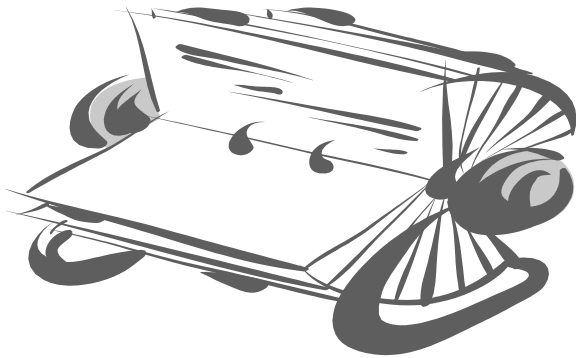
