DECEMBER 2013 ADVOCACY COMMITTEE REPORT

Discussion with Jonathan Bromberg, Assistant Planner for the Capital Area Transportation Authority

At our monthly meeting, we had a wide ranging discussion with Mr. Bromberg, focusing mainly on the East Lansing Multimodal Station (AKA new Amtrak station). We stressed the need for at least twenty bike racks and some bike lockers. Design elements for the project will have an overhead cover for the bike racks and sharrow markings on the road. In the case of a proposed Bus Rapid Transit system for the Michigan/Grand River Corridor, 2014 will see an environmental assessment for the system. A planning charrette and a focus group (format to be determined) will take place in the spring. Finally, we suggested that there should be bike parking at busy stops along bus routes since bus bike racks are often maxed out.

U.S. Housing & Urban Development work plan for non-motorized traffic

The Winter regional NMT forum will be devoted to pedestrians/walking issues. The Spring meeting will cover making connections to the various trails, pathways, and bike lanes in the region.
