JANUARY 2015 ADVOCACY COMMITTEE REPORT

Dean Brailey will represent TCBA at the annual Bike Summit in Washington, DC in March.

Tim Potter is working to engage MSU police more in bike safety matters. MDOT is working on a re-design for the intersection of Bus-69 (Old M-78) at Marsh Road in Bath Township. The plan initial plan is that all traffic on Marsh Road will be blocked from going straight across Bus-69 and would have to proceed via an indirect left turns with two rights. Bath Township officials are working with the MDOT Lansing TSC (transportation service center) to modify the plan so that non-motorized users will be able to proceed straight northbound or southbound at the intersection. Dan Stockwell is the TCBA lead on this. Dan Stockwell is leading efforts in Bath Township to improve access for non-motorized travel. There are plans to install bike racks in parks and to provide more paths for non-motorized travel. Dan also is planning a Bath Bike day, with the hope of enlisting help from other members of TCBA. MSU plans to have valet bike parking in an indoor facility for home football games. Tim Potter is working on this. Several members attended the Ingham County Parks Commission trails planning meeting on January 26. The Committee continues to push hard on Ingham County for a non-motorized facility on Okemos Road between Jolly Road and Jackson National Life. News of plans for new housing on

Okemos Road north of Jolly Road is a further call to press this issue.

DEAR UNCLE MILTIE

We are so happy to be sending you our THANKS for being such a wonderful long-time TCBA volunteer, who became our friend. We think you are the kind of man /person we all strive to be: full of life and love, with a little mischievousness thrown in!!

Pat Josephs (ridden DALMAC 29 times) writes:

About 35 years ago I began riding and met Ed and Roxanne Usewick who kept telling me about a ride of several days duration, called DALMAC. I had never heard of it before then, so I signed up and went. I was scared to death, for I'd be riding my bike for four days without my husband who don't ride, and knowing no one else but Ed and Roxanne. I met another woman named Carol, and we rode together. I'm a slow rider so it won't surprise you to learn that I met Uncle Milt on this first ride! He was one of the SAG drivers who keep their eyes on the slowest of the bikers all day every day to make sure they get in to camp on time. During one of those DALMAC trips I got sick and he picked me up and let me ride in his van for a while. (I really didn't understand what SAG drivers did, so I kept telling him that I was sorry. He reassured me that that was his job.) I had so much fun on that first DALMAC, I continued to sign up and ride annually. Every year at registration we would greet each other with a kiss.

Several years later I met Charlie Parmelee and we rode together. Later in the 1980s I met Jane Reagan. We all liked to stop at swimming holes and have long lunches so we were always last, always riding right on the edge of the SAG line. Soon we realized we needed to name our group, and we became TEAM LOLLYGAG. It truly describes our style of bike touring!! Uncle Milt always egged us on to "GET MOVING" because we were always at or behind the SAG timeline. The first few years he drove with his daughter and granddaughter. They also kept trying to keep us moving.

Later years he met and married an angel named Gloria.

Our group would dance together at the gas station in Beal City every year. We'd sit and gab together in Farwell. When DAL-MAC ended in St. Ignace in the first 20 or so years, we ate dinner in St Ignace at the Flame and recapped the week's events. One year in Petoskey at the old high school, Uncle Milt put on James Brown's "I feel good" full blast on his van radio, opened the doors and we danced all the way to breakfast!

Eventually Uncle Milt admitted that he really liked TEAM LOLLYGAG in the back of the pack, because we were experienced riders, and we would let him know if there were any riders behind us who may need help. (He knew that Charlie was able and often helped change flat tires etc., whenever he could. I remember more than once, stopping to help a rider and staying with them until Uncle Milt arrived.

I rode DALMAC 29 times, Charlie 27 times, Jane 25 times.

Our friendship grew and went past DALMAC trips. My husband Dave, my mom and I also spent time with Milt and Gloria, along with Clayton and Bev, during winters in Florida. We also attended church together so I also know that Milt is a faith-filled man

My mother has Alzheimer's so I understand what Milt and Gloria are going through. I want you both to know that we appreciate and love you both.

Jane Reagan (ridden DALMAC 25 times) writes:

It may be hard for someone who's never done a bike tour to understand why riders sign up for an annual ride like DALMAC year after year, after year. Well, it's people like Uncle Miltie who make DALMAC such an extraordinary experience. If you want to think of the trip as a bike "race", you can hammer all day for four or five days. Or, you can become a member of TEAM LOLLYGAG and jump in every lake, stop at every ice cream stand, and get to know the SAG drivers like Miltie, over the years. The dedication Milt (and later Gloria) to assuring as many riders as possible had a fun, positive experience no matter what their biking speed or strength, was really remarkable, in my opinion. He took the job of SAG driver seriously but had a LOT of fun at the same time. His sense of humor was infectious and those who rode with him (his son, granddaughter and wife) mastered the technique of getting our slow-butts to move up the road a little faster, while having fun and being sometimes hilarious. One of my favorite scenes, repeated day after day, year after year on DALMAC, is Uncle Miltie's van pulling alongside us riders and he and his passenger waving, or making some snarky remark or making the universal signal: "is everything OK?", that required a mere "thumbs up" signal back from us. It is/was SO reassuring for a slow biker to know someone's watching out for you.

But it's people like Milt, who I think symbolizes the friendly, welcoming spirit of the TCBA and all its rides, who got me coming back for 25 DALMAC trips and many others. Over those years we met more members of TEAM LOLLYGAG: Bruce Mitchell, Charlotte Koger, Bob Grieve, Mike Payne (although he's much faster than the rest of us) and a few others. We'd find ourselves riding together just because we love that Lollygagging pace!!

In my encouragement to friends to sign up for an organized ride, I always tell people, "bikers are THE NICEST people". And Milt, you and Gloria embody that simple phrase. Thank you for your decades of service to TCBA, all the riders who participated in the rides, and all those you left with a stronger love for this great sport.


