ADVOCACY COMMITTEE REPORT**

Chandler Crossing developments

The new management, WestPac, has made public announcements that it would like to “give the area more of a residential feel.” Committee member Art Slabosky sent WestPac a letter urging them to expand on their public statements and to capitalize on the area’s closeness to the North Tier Trail (NTT) access by adding bike- and pedestrian-friendly features. He will also contact the City East Lansing about advertising on the length of the NTT.

Since Bath Township is the responsible unit of government for the Westpac properties, Tom Hardenbergh and Dan Stockwell will work with the Township on its overseeing of Non-Motorized Transit (NMT) features.

Bath Township (BT) Advocacy Subcommittee

Tom and Dan had a productive meeting with the Township Parks & Recreation Department about a TCBA ride originating at the Thursday outdoor market in Couzens Park. It would be a Class C (20 mile) ride around the Township and be the first TCBA ride originating in Bath Township. There will also be a Bike Rodeo in August as part of Bath Days Festival

April 18 Fred Meijer CIS Trail Dedication:

An 11:00 a.m. Ribbon Cutting will take place at Pavilion by the depot in St. John on the Trail. Two rides are tentatively planned (details are forthcoming). The first will be from Owosso to St. Johns sponsored by House of Wheels. The second is from Ionia to St Johns sponsored by Dan's Bike Shop.

When: Wednesday May 20, 2015 from MSU to Capitol

The Ride of Silence exists:

- To **HONOR those who have been injured or killed**
- To **RAISE AWARENESS that we are here**
- To **ask that we all SHARE THE ROAD**

TIME: Gather between 5:15 - 6:05 pm, roll-off at 6:30 pm sharp.

RAIN DATE: Saturday, May 23rd, 10 am (start location, route will be the same)

WHERE: Gather at MSU Wells Hall courtyard (east side of Wells Hall) for sign-in, tying on of arm-bands, etc. We roll off at 6:30 pm sharp to The State Capitol. Bathrooms are available in Wells Hall.

On May 20th at 6:30pm, We will join cyclists across the globe in the 2015 Ride of Silence, a silent procession that honors family and friends who have been injured or killed while cycling on public roadways.

The Ride of Silence is a free ride that asks cyclists to ride no faster than 12 mph (20 kph) and remain silent during the Ride.

The Ride, which is held during Bike Safety month, aims to raise the awareness of motorists, public safety and city officials that cyclists have a legal right to the public roadways. The Ride is also a chance to show respect for our brothers and sisters who have been killed or injured.

The Ride of Silence was originally organized in Dallas TX in 2003 as a one-time event, when a nationally ranked endurance cyclist was struck and killed by a passing bus. Since that single Ride, on May 21st 2014, the Ride of Silence took place in 314 locations worldwide, in 49 states and the D. of C., in 21 countries and across all 7 continents.

Helmets are mandatory. Lights are suggested. Please arrive and be ready to ride by 6:30 PM. Rides depart at 7:00 PM.

Many locations will provide black & red arm-bands, to honor fellow cyclists killed or injured.

The MidMI Ride of Silence will be the only TCBA Club Ride on Wednesday evening May 20

IN REMEMBRANCE -

R. Thomas Martin - 8-21-1945 / 3-4-2015—By: Tom Hardenbergh

Tom joined TCBA in 1974. Tom was not the bicycle activist like his work acquaintance and club founder John Czarnecki was, but he was certainly an active bicyclist. In the fall of '74 shortly after becoming a member, he volunteered to be a road captain; a good club position for him because Tom was on his bicycle on the road (rollers in the off-season) as often as he could be. A state employee his entire career, Tom was an outdoorsman at heart. He rarely drove to work, riding as long as conditions permitted into the winter and walking to his office in downtown Lansing until spring's snow-melt cleared a lane. Under Tom's leadership, the TCBA ride program expanded in 1974-75. There were all types of rides. Tom led many himself (usually 50 miles or more) and encouraged other members to lead rides for all levels of rider. Tom loved to ride and was a strong cyclist; riding fast over a long distance was his forte and it was fun. Witness his Six County Ramble in September 1975. Tom wrote "Six counties in one day? Why not! 100 miles" and in February 1976 the Washington's Birthday Ride with the billing "just as old George was brave to cross the Delaware in a boat in winter, Tom Martin is brave enough to lead a ride regardless of weather". Tom was elected club treasurer for 1975-76. During that year, Tom continued to lead rides and followed his love of reading and riding by starting a club library. Tom was elected club VP in 1976. When President Gene Losey departed for Elmhurst IL, Tom stepped-up to serve as president for the remainder of 1977. In 1978, Tom took on the hard task of editing and issuing the Chainwheel Chatter. In 1979, Tom took a well-earned break. Understandably, he had to spend more time with his growing family than on club business. However, he remained very active riding club events. During these years, Tom pulled a Bugger with his children aboard, three in all, and each had their DALMAC experience. Nobody else ever did that. Tom served on The DALMAC Fund committee for many years, his wise counsel providing confidence we were giving the hard-earned funds to worthy projects. A unique and fitting take-away from Tom's funeral service was a book-mark with a photo of Tom wearing a bicycle jersey, a thumbnail road map of the tri-county region, and the caption "thoroughly enjoyed the ride". You sure did Tom and we sure enjoyed having you along with us.

Memories By: Steven Leiby

Every time I drive down US 23 towards Ann Arbor and go under Territorial Road, I remember a 1977 ride with Tom Martin.

Tom passed away from cancer on March 4th. He is survived by his wife of 47 years, Mary Ann, and two daughters, Anna Marie and Suzanne (and their families).

Tom joined TCBA in the early 1970s. He rode to work almost year round before it became fashionable. He was noted for turning a 4 mile commute into a 20 mile ride. He rode over 140,000 miles.

Tom served many years on the DALMAC Fund Committee. He rejoined the DALMAC Committee last year working on routing. Ohio Road was his big contribution to DALMAC the year I was Events Director.

My most memorable ride with Tom was in 1977. He called me and asked if I wanted to ride to Plymouth. He said Mary Ann had a stamp collecting meeting. Truth be told, Tom was the real stamp collector.

Sure, why not ride to Plymouth. I had never ridden to Plymouth before.

A couple of things you need to know about Tom's riding; he was very strong and didn't stop.

With that in mind, I did something I had never done before, put a second water bottle on my bike. Did I tell you, he wouldn't stop? My jersey pockets were filled with food.

We set off from the MSU parking lot at Mt. Hope and Farm Lane at 5:30 pm and made our way down to Territorial Road. A left turn and we were headed to Plymouth. US 23 north of Ann Arbor, not a problem, over the highway we flew.

We arrived in Plymouth well before dark and headed to Tom's favorite restaurant; McDonalds. Mary Ann was waiting for us.

Tom, thanks for all you did for TCBA and all of the great rides. Mary Ann, thanks for letting Tom ride with us. We miss him already.

100,000 METRE T-SHIRT RIDE**100,000 Metre T-Shirt Ride - “Back to the Ledge”**
